

## Rules of the "Earn 5% of an EGLD" campaign

Campaign period: June 1 - July 30, 2023

1. Campaign organizer: Tradesilvania SRL
2. Address: Constantin Brancusi no. 176, et. 3
3. Registration number: 39400924

#### 4. Eligibility:

- a. The campaign is open to natural persons who are of legal age and who meet all the registration requirements in the Tradesilvania platform.
- b. The campaign is only valid for new users who register on the Tradesilvania platform between June 1 and July 30, 2023
- c. Users must be residents of the European Economic Area.
- d. Registrations can take place both by using the application (IOS/Android) Tradesilvania and by accessing the platform with the help of an internet browser.

#### 5. Mechanism of the campaign:

- a. Each new user registered in the Tradesilvania platform during the mentioned period will automatically receive 0.05 EGLD (MultiversX).
- b. Cryptocurrencies will be awarded in order of registrations, until the maximum number of users is reached.
- c. The amount of 0.05 EGLD will be transferred by the organizer to the user's EGLD wallet within the Tradesilvania platform, at the latest 5 working days from the date of his registration in the platform.

#### 6. The value of cryptocurrencies:

- a. Each newly registered user will receive 0.05 EGLD (MultiversX) in his account by Tradesilvania after account validation.
- b. The value of cryptocurrencies may vary according to market fluctuations and will be determined according to the exchange rate at the time of award.



## **7. Use of cryptocurrencies:**

- a. Users can use EGLD (MultiversX) cryptocurrencies in the Tradesilvania platform according to the functionalities and restrictions of the terms and conditions of use of the platform.
- b. The company is not responsible for the inappropriate use of cryptocurrencies by users.

## **8. Limitations and restrictions:**

- a. Each newly registered user can receive 0.05 EGLD (MultiversX) only once.
- b. Users must comply with the Terms and Conditions of the Tradesilvania platform and any other policy or specific rule of the platform.

## **9. Taxes and fiscal obligations:**

- a. It is the users' responsibility to fulfill all applicable tax obligations regarding cryptocurrency earnings or transactions.
- b. The campaign organizer does not assume any responsibility for any fiscal or legal consequences resulting from users' participation in the campaign.

## **10. Confidentiality and protection of personal data:**

- a. The campaign organizer undertakes to protect the confidentiality and security of users' personal data.
- b. By participating in the campaign, users agree that certain personal information will be collected and processed in accordance with the privacy policy of the Tradesilvania platform and with the legislation in force regarding the protection of personal data.

## **11. Waiver of rights:**

By participating in the campaign, users waive any request, action or claim against the organizer or the parties involved in the campaign.



## 12. Exemption from liability:

- a. The campaign organizer does not assume any responsibility for possible technical failures, service interruptions or other problems that may affect the participation of users or the awarding of EGLD (MultiversX) cryptocurrencies.
- b. The organizer is not responsible for any loss, damage or injury caused by participation in the campaign or the use of EGLD (MultiversX) cryptocurrencies.

## 13. Legal provisions:

- a. Any aspects not regulated by this regulation will be resolved in accordance with the legislation in force in Romania.
- b. If any of the provisions of this regulation is declared void or invalid, the other provisions will remain in force to the extent permitted by law.

## 14. Final provisions:

- a. The campaign is subject to the legislation in force in Romania.
- b. The organizer reserves the right to modify or cancel the campaign at any time, without providing explanations or prior notifications.
- c. Participation in the campaign implies acceptance of this regulation and the terms and conditions of use of the Tradesilvania platform.
- d. Any dispute related to the campaign will be resolved amicably or, in case of disagreement, will be submitted to the competent courts.
