

Tradesilvania Spotlight "30 EGLD Airdrop" Campaign Rules

Campaign Period: July 17 - August 31, 2023

1. Campaign Organizer: Tradesilvania SRL, VAT: 39400924

2. Address: Constantin Brancusi nr 176, 3rd floor

3. Campaign registration number: 91/12.07.2023

4. Eligibility:

- a. The campaign is open to all individuals of legal age who meet the registration requirements on the Tradesilvania platform, whether they are existing customers at the start of the campaign or new customers registered during the campaign period.
- b. The campaign is valid only for users who register through the Tradesilvania platform, in the Spotlight section, and choose to participate in the "30 EGLD" Airdrop.
- c. Participants must be part of the Tradesilvania Telegram community, which means joining the Telegram group through the invitation link https://t.me/tradesilvaniacom, also available within the platform.
- d. To be eligible for prizes, participants must share at least one of Tradesilvania's campaign-related posts on Twitter, Instagram, Facebook, or Linkedin, mentioning (tagging @) the corresponding Tradesilvania account.

5. Campaign Mechanism:

- a. Participants can enter the Airdrop campaign by obtaining a free ticket on the Tradesilvania platform, accessing the Spotlight section, and selecting "30 EGLD".
- b. Each participant is entitled to purchase only one free ticket to participate in the Airdrop.
- c. Participants must join the official Telegram group of Tradesilvania and share at least one of Tradesilvania's campaign-related posts on Twitter, Instagram, Facebook, or Linkedin, mentioning (tagging @) the corresponding Tradesilvania account.
- d. The prize allocation will be done through a random selection of three winners from the total number of eligible participants in the EGLD Airdrop campaign.

6. Prizes and Their Value:

- a. Within this Airdrop campaign, three prizes will be awarded, each consisting of 10 EGLD (MultiversX) for each of the three randomly selected winners from the list of eligible participants.
- b. The three winners will each receive 10 EGLD (MultiversX) as their prize, in the form of cryptocurrency.

- c. The value of the cryptocurrencies is determined by the market price. This campaign and the current rules stipulate that the prizes are offered in a quantity of EGLD cryptocurrency, unrelated to its market value. Users can use the cryptocurrencies won as they see fit, without any conversion required, either at the time of award or at any future moment, into a fiat currency or other cryptocurrency.
- c. The winners will be responsible for any taxes, fees, or other legal obligations related to the receipt and use of the prizes, according to the legislation in force in their country of residence.

7. Winner Selection:

- a. The winners will be randomly selected from the pool of eligible participants, ensuring a fair and equitable process for determining the three winners of the 10 EGLD prizes each.
- b. If, as a result of the random selection of winners, it is found that one or more of them do not meet the eligibility criteria to receive the prizes, they will be excluded, and other winners will be randomly chosen from the list of eligible participants according to point 6.b) mentioned above.

8. Announcement of Winners:

- a. The winners will be announced within 10 business days from the end of the campaign, by September 10, 2023.
- b. The announcement of the winners will be made on the Tradesilvania platform and in the Telegram community group.
- c. If, as a result of the random selection of winners, it is found that one or more of them do not meet the eligibility criteria, new winners will be randomly selected from the list of eligible participants according to point 6.b) mentioned above.

9. Prize Allocation:

- a. The winners will be contacted privately to be informed of winning the prize.
- b. The prizes worth 10 EGLD (MultiversX) each will be allocated to the Tradesilvania wallet of each winner, from where they can use the cryptocurrencies according to their preference.

10. Use of Cryptocurrencies:

- a. Users can use EGLD (MultiversX) cryptocurrencies in the Tradesilvania platform according to the functionalities and restrictions in the Terms and Conditions of use of the platform.
- b. The company is not responsible for any improper use of cryptocurrencies by users.







11. Legal Provisions:

- a. Any aspects not regulated by these rules will be settled in accordance with the current legislation in Romania.
- b. If any provision of these rules is declared null or invalid, the other provisions will remain in force to the extent permitted by law.

12. Final Provisions:

- a. The campaign is subject to the current legislation in Romania.
- b. The organizer reserves the right to modify or cancel the campaign at any time without providing prior explanations or notifications.
- c. Participation in the campaign implies acceptance of these rules.
- d. Users must comply with the Terms and Conditions of the Tradesilvania platform and any other specific policies or rules of the platform, accepted during the enrollment process on the Tradesilvania platform.
- e. Any disputes related to the campaign will be resolved amicably or, in case of disagreement, will be subject to the competent courts.

13. Taxes and Tax Obligations:

- a. It is the responsibility of users to fulfill all applicable tax obligations regarding earnings or cryptocurrency transactions.
- b. The campaign organizer assumes no responsibility for any tax or legal consequences resulting from users' participation in the campaign.

14. Confidentiality and Personal Data Protection:

- a. The campaign organizer is committed to protecting the confidentiality and security of users' personal data.
- b. By participating in the campaign, users agree that certain personal information will be collected and processed in accordance with the privacy policy of the Tradesilvania platform and with the current legislation regarding personal data protection.
